## 2. Financial Report

Parish expenses are closely following budget and the parking lot revenue is higher than anticipated.

Morning Star Refugee Support Group now has a separated account at the credit union to ensure funds held in trust are kept secure.

There was discussion about options for strategic retirement of the current overdraft through a fixed term loan from Access Credit Union. This will be revisited and a recommendation made to the congregation at the AGM.

## 3. Annual Meeting Preparation
